# 2007 **KART** ANNUAL MEMBERSHIP AND BOARD OF DIRECTORS MINUTES

The annual KART Membership meeting was held Saturday, November 10th, 2007 at Jess & Jim's Steakhouse in Martin City, MO.

President Mike Baldus called the meeting to order at 8:17 a.m. and explained the format of the meeting. This portion of the meeting will be an open meeting for membership input.

A notice of the meeting was printed in Issue #3 of the KART Newsletter and posted on the website.

Directors present for the membership portion of the meeting were Jim Edgington, David Munden, Bernie Baldus, Dennis Scott, Frank Merando and Linda Baldus.

Mike Baldus reviewed a membership report and determined that there was not a quorum present.

President Mike Baldus asked for introduction of the audience. Present were: Julie Munden, Kenny Taylor, Steve Trowbridge, Tom Trowbridge, Kelly Read, Jim Stroud, Roger Hatcher, Bryan Norman, Dan Davis, Wes Oakley and Maysha Phillips.

Mike Baldus announced that James Kopeck has resigned.

Letters from the memberships were reviewed:

Noe Chapa sent in a letter on April 24<sup>th</sup> regarding the TaG Master Weight. Linda Baldus stated it was just to clarify the weights for the Nationals.

Kelly Read sent in a letter on January 31<sup>st</sup> regarding the Box Stock under F.3.k. Clarification of the class name was discussed. Dennis Scott mentioned that WKA was also in the process of updating their rules for the Briggs & Stratton Animal Classes. Further discussion will be held during the Enduro Section of the Board Meeting.

DJ Ortiz sent a letter on July 12<sup>th</sup> regarding the Rotax engines. Bernie Baldus agreed with the letter and said that it is obvious.

Mike Baldus read a letter from Wally Stallcup dated September 13<sup>th</sup>. Kelly Read asked for clarification regarding this letter. David Munden stated that he talked with Wally Stallcup regarding the situation.

Kelly Read sent in a letter on September 26<sup>th</sup>. The letter was discussed and it was decided that more discussion would be held during the Enduro portion of the meeting. Roger Hatcher asked that if the discussion was held off until the Enduro section will the members have a voice. Jim Edgington stated that this was the membership portion of the meeting and even though the directors have been able to review the letters he felt that it should be open for discussion. Discussions were held on each issue and further discussion will be held during the Enduro Section of the Board Meeting.

A lengthy discussion was held regarding the 4-cycle tech at Road Race events.

James Kopeck's resignation letter was discussed.

Bernie Baldus motioned to have DJ Ortiz replace the remaining term for James Kopeck.

Discussion was made regarding Brian Stuart accepting the open Speedway Director position. Dennis Scott motioned that Brian Stuart be the new Speedway Director and Frank Merando second. Brian Stuart was appointed Speedway Director.

The floor was opened for discussion / questions from the audience.

Wes Oakley asked how we arrived at the current class weights. Jim Edgington stated that they weighed the participants of the class and set the weights accordingly.

Kenny Taylor asked if there was any way to check for oil during tech. Dennis Scott provided him a method on how to check.

Discussion was held regarding spec race gas for animal sportsman road race class. Suggestion was made to adjust the meter settings and to specify a fuel station at each track. No action was taken.

National Presentations:

Sprint Presentations - JRP / Tulsa Kart Club questionnaire was reviewed, but there was not a representative present. Lake Garnett questionnaire was reviewed, but there was not a representative present.

Speedway Presentations - WaKeeney Kart Club questionnaire was reviewed, but there was not a representative present.

Road Race Presentations - Heartland Park Topeka questionnaire reviewed, Mike and Linda Baldus represented the track. They stated that it will be the same set up as last year.

Mike Baldus closed the general membership portion of the meeting at 12:03 pm and a lunch break was held.

Board Meeting Minutes:

The 2007 Annual KART Board of Directors meeting was held at Jess & Jim's Steakhouse in Martin City, MO on Saturday November 10th, 2007.

The meeting was called to order at 1:15 p.m. and President Mike Baldus explained the format of the meeting. A notice of the meeting was printed in the 3rd issue of the KART newsletter and posted on the website.

Roll call was made and the directors present were: Jim Edgington, David Munden, Dennis Scott, Frank Merando, Bernie Baldus, Linda Baldus, Brian Stuart. Absent was James Kopeck, DJ Ortiz, Sheldon Birmingham.

An election report was reviewed. Directors elected were Sheldon Birmingham - Enduro, Mike Baldus - President. Dennis Scott motioned to accept the election. Frank Merando second, all in favor.

The general ledger, money market surplus and tech fund reports were reviewed and discussed.

The magazine report was reviewed.

The pit pass report was reviewed and WaKeeney Mini Speedway was the number one user this year.

A discussion was held regarding the newsletter. Mike Baldus proposed that we have the newsletter online instead of mailing it out. There would be a notification put in the Rules and Technical Guide to offer a hard copy of the newsletter.

The national championship and series reports were reviewed and discussed.

The sanction fund report was reviewed.

Jim Edgington motioned to accept the 2006 Board of Directors and Membership meeting minutes. David Munden second and all in favor.

The KART Committees and Coordinators were reviewed and the following changes were made:

Delete Keeper of the Point (MASS), Gulf Coast Sprint Series and Keeper of the Points (S. Sprint Series). Dennis Scott stated that we needed to remove Mike Smith from the list also but wanted to double check with him.

National Championship Selections:

Sprint - Bernie Baldus voted for Lake Garnett. Lake Garnett was awarded Sprint Nationals. Dates to be determined.

Speedway - Frank Merando, Dennis Scott and Brian Stuart voted for WaKeeney Kart Club. WaKeeney Kart Club was awarded Speedway Nationals. Dates to be June 12<sup>th</sup> - 14<sup>th</sup>, 2008.

Enduro - David Munden and Jim Edgington voted for Heartland Park Topeka. Heartland Park Topeka was awarded Enduro Nationals. Dates to be June 27<sup>th</sup> - 29<sup>th</sup>.

A discussion was held regarding rib protectors. Bernie Baldus motioned to have rib protectors mandatory for all divisions as discussed. All drivers in Kid Kart, Rookie, Jr I and Cadet classes in all divisions are required to wear a chest protection device with SFI specification 20.1 certification any time they are on the race track. The use of chest protection is recommended for all sit up type kart drivers. Jim Edgington second and all in favor.

A discussion was held regarding weekend FAMILY memberships. No action was taken.

A discussion was held regarding drawing for positions for an Enduro National Championship event. Clarification will be posted regarding drawing for positions.

A discussion was held regarding helmet classifications. Bernie Baldus motioned to have the K98 helmet removed. David Munden second and all in favor.

Linda Baldus motioned to publish notification that as of 01/01/2010 the helmet classification ratings will be SA2005, K2005, M2005. Frank Merando second and all in favor.

A discussion was held regarding Leatt-Brace Moto Neckbrace. Linda Baldus motioned to update D.8.I to include the Leatt-Brace. Jim Edgington second and all in favor.

A discussion was held regarding Unlimited Fuel. Clarification will be posted regarding the Unlimited Fuel.

A break was held and the meeting was called back to order at 3:05 p.m.

A discussion was held regarding the Raptor Flywheel update. Dennis Scott stated that he will submit updates regarding the flywheel.

A discussion was held regarding the TaG Cadet Enduro Class. No action was taken.

A discussion was held regarding TaG USA Rules. Bernie Baldus motioned to have the rules frozen 60 days prior to the National events. All in favor.

A discussion was held regarding the Animal Survey. Further discussion would be held during the Enduro Section of the Board meeting.

A discussion was held regarding Proof of the Tech Guide. Speedway appointed Dennis Scott, Sprint appointed Bernie Baldus and Enduro appointed Jim Edgington to review the Tech Guide.

A discussion was held regarding Garnett corner workers. Mike Baldus stated that he will address the concerns with Ron Anderegg.

A discussion was held regarding the Annual Board Meeting Date. Bernie Baldus motioned to have the Annual Board Meeting on November 8th, 2008.

2-Cycle Tech: Roger Hatcher and Jim Stroud have clarifications regarding the Kid Kart class. They will submit them to the Administrative Office in the next week.

2-cycle Rules Clarifications submitted November 15<sup>th</sup>:

Kid Kart - C50 - C51:

Combustion Chamber: As manufactured. All threads are to be intact. Plug threads may be repaired, but must be full length.

Port Height Check: Check with 3mm (0.120") rod 3.00" long (max) inserted approximately 0.25" into port. Rod should be unsupported. Exhaust: 1.200" min Intake: 0.370" max

Base Gasket: Must be in place

Diagram should read C-50/51

Bearings: No ceramic bearings

Ignition Timing Check: Remove starter cover, install dial indicator in plug hole, zero at TDC. Rotate flywheel counter clockwise until first magnet is completely exposed. Rotate back clockwise until right edge of magnet aligns with left edge of coil. Dial indicator reading 0.050" - 0.060". (Insert diagram)

4-Cycle Tech: Dennis Scott has some clarifications that he will submit to the Administrative Office in the next week.

4-Cycle Rules Clarifications submitted December 4<sup>th</sup>.

Pg 53 #19 - Cylinder Head: Wording changed to - Stock B & S part #555558. Machining of gasket surface only allowed. No machining of parts allowed. Bosses on back of head, just below valve cover gasket surface may be tapped for attachment of header supports. Depth of head at shallow part of head 0.011" min. Depth at floor of head 0.319" min. Depth of top of valve seat 0.360" max, 0.335" min. Head thickness measured from head gasket surface to head plate gasket surface is 2.420".

Pg 52 #5 - Remove B&S recommends intake. Add: Pulsing from intake allowed in sportsman gasoline fuel classes only.

Pg 52 #4 - Add following after Also may be drilled ...fuel pump. Pulsing from intake allowed in the sportsman gasoline fuel classes only.

Pg 53 #30 - Change wording to read: Connecting Rod: Stock connecting rod or any unmodified series produced aluminum alloy rod that is available to the karting industry is allowed. **MUST MEET STOCK SPECS.**

Pg 52 #3 - Change PZ Model 15 to Model 22

Pg 52 #9 - Add to chart on Max lift is .257" line - Min lift is 0.252" on both Intake Lobe and Exhaust Lobe

Pg 52 #13 - Change wording to read following: B&S and after market head gaskets are allowed of stock design. Minimum thickness 0.042", measured in four places between head bolts and from inside of gasket with micrometer. No aluminum or copper head gaskets allowed.

Pg 52 #16 - Add after No grooves . . . Etc. Minimum intake and exhaust valve length 3.250"

Pg 50 #29 - Add after Heat treating ....legal. Minimum crankshaft journal diameter is 0.990".

Pg 49 #8a - Remove With the .696 ....when opened.

Pg 49 #8c - Add following after Bore .695"....bore with the .696" NO-GO check the flange end of carb and then with the .696 NO-GO in the back side of the carb, it cannot hit the butterfly when opened.

Pg 49 #6 - Change 5,000 ohms max to 6,000 ohms max

Pg 54 #8 - Change to FUEL PUMP: Fuel pump must be pulsed only from crankcase upper oil fill cap.

Pg 54 #4 - Change to: CYLINDER DECK: Piston pop-up cannot exceed .005" above block surface in the center of the piston.

Speedway Business: Dennis Scott stated that there will be discussion between the directors and they will submit the changes to the Administrative Office.

Pg 29 E.2 - Update following: The Speedway directors .... End of the 2008 season.....

Enduro Business: Jim Edgington motioned to remove the TaG Enduro and Senior TaG Heavy classes. David Munden second, all in favor.

Jim Edgington motioned to increase the weight of the Briggs & Stratton Animal Light Experimental class to 410 lbs and to rename it Briggs & Stratton Sportsman Experimental. David Munden second, all in favor.

Jim Edgington motioned to change the name of Briggs & Stratton Animal to Briggs & Stratton Animal Sportsman. David Munden second, all in favor.

Jim Edgington motioned to add the following under Sprint TaG Senior Rules: If you have to get out of the go-kart you can NOT restart the engine. David Munden second, all in favor.

Jim Edgington motioned to change the Sprint Piston Port Experimental class to be an open fixed pipe class with the weights being Yamaha Motor 350 and Piston Port Motor 390. David Munden second, all in favor.

Sprint Business: Bernie Baldus motioned to add the following notes under all Sprint TaG Classes: Use of starter will NOT result in penalty and header may be welded as repair as long as the header flow is not changed.

The Directors would like to thank Debbie and Mike Van Noy and Jess & Jim's Steakhouse for the use of their meeting room and hospitality.

The meeting was adjourned at 6:05 p.m.

After the meeting it was brought to the Road Race Directors that a letter did not make it into the board book to be reviewed. Dennis Tapp sent in a letter on October 10<sup>th</sup> regarding the Sprint CIK 125 and Sprint 80cc Shifter bodywork. The letter was sent to the directors and the final unanimous decision was to change the 10" to 12".




